Whereas it appears to the Governor of Punjab that to meet the challenge of rapid growth of Khem Karan (NP) of Tarn Taran district and to provide a workable framework for its comprehensive planned and regulated development, the preparation of statutory master plan of Khem Karan (NP) is very essential. Hence in order to develop Khem Karan (NP) and its surroundings in an orderly manner and to prepare its master plan under "The Punjab Regional and Town Planning and Development Act, 1995," the Governor of Punjab is pleased to declare the Local Planning Area of Khem Karan (NP) within the meaning of sub section (1) of section 56 of "The Punjab Regional and Town Planning and Development Act, 1995". The total area proposed for Local Planning Area, Khem Karan (NP) is 45,363 hectares (1,12,094 acres) including Khem Karan (NP) and 85 adjoining villages. The schedule of boundary of Local Planning Area is given below:-

SCHEDULE OF BOUNDARY

NORTH: Starting from point 'A' which is the common meeting point of revenue boundary of village Wan (HB No. 65), Indo-Pak international boundary and revenue boundary of village Dal (HB No. 66) of Local Planning Area, Bhikhiwind. Then moving towards east along the northern and eastern revenue boundaries of village Wan (HB No. 65), village Hardo Chak Bamba (HB No. 71), crossing Kala Pani drain and moving along the northern and eastern revenue boundary of village Madar Mathra Bhagi (HB No. 72), eastern revenue boundary of village Beharwal (HB No. 89), crossing Kasur Nala and moving again along the eastern revenue boundary of village Beharwal (HB No. 89), northern revenue boundaries of village Mahmudpura (HB No. 88), village Ballianwala (HB No. 93), western revenue boundary of village Jagatpura (HB No. 91), western, northern and eastern revenue boundary of village Fatehpur (HB No. 90), eastern revenue boundaries of village Jagatpura (HB No. 91), village Daudpura (HB No. 92), crossing Khem karan-Bhikhiwind (SR-15) road and moving again along the eastern revenue boundaries of village Daudpura (HB No. 92), village Dibipura (HB No. 94), northern revenue

boundaries of village Valtoha (HB No. 85), village Warnala (HB No. 123), village Punian (HB No. 122), village Gharyala (HB No. 127), village Thatha (HB No. 128), northern and eastern revenue boundary of village Gharyala (HB No. 127), crossing Khem karan-Patti (MDR-62) road and moving again along the eastern revenue boundary of village Gharyala (HB No. 127), northern revenue boundary of village Dhagana (HB No. 156), crossing Khem karan-Patti railway line and moving again along the eastern revenue boundary of village Dhagana (HB No. 156), northern revenue boundary of village Shahid (HB No. 157), northern and eastern revenue boundaries of village Barwala (HB No. 161), village Jaur Singhwala (HB No. 159) upto point 'B' which is the common meeting point of revenue boundary of village Jaur Singhwala (HB No. 159), village Saido (HB No. 160) and village Sabhrai (HB No. 190) of Local Planning Area, Patti.

EAST:-

Thence from point 'B' moving towards south along the southern revenue boundary of village Jaur Singhwala (HB No. 159), eastern revenue boundary of village Sito Nauabad (HB No. 191), northern and eastern revenue boundary of village Sito Mah Jhungian (HB No. 347), eastern revenue boundary of village Dhumniwala (HB No. 348), northern revenue boundary of village Gadhaike (HB No. 349), northern, eastern and southern revenue boundary of village Bhura Hithar (HB No. 350), moving along the common district boundary of Tarn Taran & Ferozepur and southern revenue boundary of village Gagarke (HB No. 345), crossing Satluj river and moving again along the eastern, southern and western revenue boundary of village Gagarke (HB No. 345), southern revenue boundaries of village Jalloke (HB No. 344), village Kot Budha (HB No. 341), village Bahlarke (HB No. 342), village Bhojoke (HB No. 337), village Jhugian Pir Bakhsh (HB No. 336), village Rahdalke (HB No. 335), eastern and southern revenue boundary of village Ram Singh Wala (HB No. 329), southern revenue boundary of village Rasulpur (HB No. 330), eastern and southern revenue boundary of village Muthianwala (HB No. 321) upto point 'C' which is common meeting point of revenue boundary of village Muthianwala (HB No. 321), district boundary of Ferozepur and Indo-Pak international boundary.

SOUTH:-

Thence from point 'C' moving towards north along Indo-Pak international boundary and along western revenue boundary of village Muthianwala (HB No. 321), crossing Satluj river and moving again along the western revenue boundary

of village Muthianwala (HB No. 321), western revenue boundary of village Jhugian Natha Singh (HB No. 319), southern revenue boundary of village Jhugian Nur Mohammad (HB No. 320), then moving towards west along the southern revenue boundaries of village Gajjal (HB No. 199), village Rattoke (HB No. 201), village Machhike (HB No. 82), then moving towards south along the eastern revenue boundaries of village Mehdipur (HB No. 203), village Mahamdiwala (HB No. 299), eastern and southern revenue boundary of village Mehdipur (HB No. 203), then moving towards north along the southern and western revenue boundary of village Mianwala (HB No. 204) upto point 'D' which is common meeting point of revenue boundary of village Mianwala (HB No. 204), Indo Pak international boundary and revenue boundary of village Chak Ladheke (HB No. 208) of Local Planning Area, Khem karan.

WEST:- Thence from point 'D' moving towards north along western revenue boundary of village Chak Ladheke (HB No. 208), southern & western revenue boundary of Nagar Panchayat Khem karan (HB No. 55), western revenue boundary of village Kals (HB No. 56), crossing Kasur Nala and moving again along the western and northern revenue boundary of village Kals (HB No. 56), western revenue boundaries of village Dhul Nau (HB No. 57), village Mastgarh (HB No. 58), village Nurwala (HB No. 59), village Sankatra (HB No. 60), village Kalia (HB No. 61), village Thathi Jaimal Singh (HB No. 63), village Rajoke (HB No. 64) and village Wan (HB No. 65) upto point 'A' which is the starting point.

The boundaries of Local Planning Area, Khem karan are specifically shown on the drawing No. DTP (ASR) 08/2017 dated 18-09-2017.

All the provisions laid down u/s 56 (2) of "**The Punjab Regional and Town Planning and Development Act, 1995,**" and all the concerned rules framed under this Act have been taken into consideration.

**EXPLANATORY NOTE REGARDING DECLARATION OF
LOCAL PLANNING AREA, KHEM KARAN,
DISTRICT TARN TARAN**

**UNDER SECTION 56 (1) OF "THE PUNJAB REGIONAL AND TOWN
PLANNING AND DEVELOPMENT ACT, 1995,"**

To regulate the development in and around the Khem karan (NP) of Tarn Taran district and to tap the potential of areas along the Khem karan-Bhikhiwind (SR-15) road, Khem karan-Patti (MDR-62) road and Khem karan – Patti railway line, the state government intends to declare the Local Planning Area of Khem karan (NP) and notify the same under section 56 (1) of "**The Punjab Regional and Town Planning and Development Act, 1995,**" in which the area of Khem karan (NP) and 85 villages in its surroundings has been included. The total area of Local Planning Area, Khem karan is 45,363 hectares (1,12,094 Acres) which has been shown on drawing No. DTP (ASR) 08/2017 dated 18-09-2017. While preparing the proposal of Local Planning Area of Khem karan NP, all the provisions laid down u/s 56 (2) of the "**The Punjab Regional and Town Planning and Development Act, 1995,**" and all the concerned rules framed under this act have been taken into consideration as mentioned below.

- a) Revenue boundaries of Khem karan (NP) & other villages and permanent features have been kept in mind for proper identification of land falling in Local Planning Area.
- b) Geographical & Locational aspects have also been taken into consideration.
- c) Major road pattern of the NP especially the development along potential on Khem karan-Bhikhiwind (SR-15) road, Khem karan-Patti (MDR-62) road and Khem karan – Patti railway line has been taken into consideration to make the planning area more accessible for proper development.
- d) To study and analyze the scope of Local Planning Area, the present population and projected population increase of Khem karan (NP) has also been taken into consideration so that projected population can be adjusted in a planned manner in near future.
- e) To enhance the industrial development, the trends of existing industrial development and expected industrial development have also been studied and analyzed and have been taken into consideration.

- f) To strengthen the economic base and commercial activities of Local Planning Area of Khem karan (NP), the need for planned development of this area has been kept into consideration.
- g) To make the periphery of the NP manageable in a proper manner, the extents of the NP and its expansion have also been considered.
- h) State and regional level planning and development aspects have also been considered so as to control the pressure on existing infrastructure and amenities.
- i) In order to keep environmental balance, the surrounding villages around Khem karan (NP) have been included in the proposed Local Planning Area.

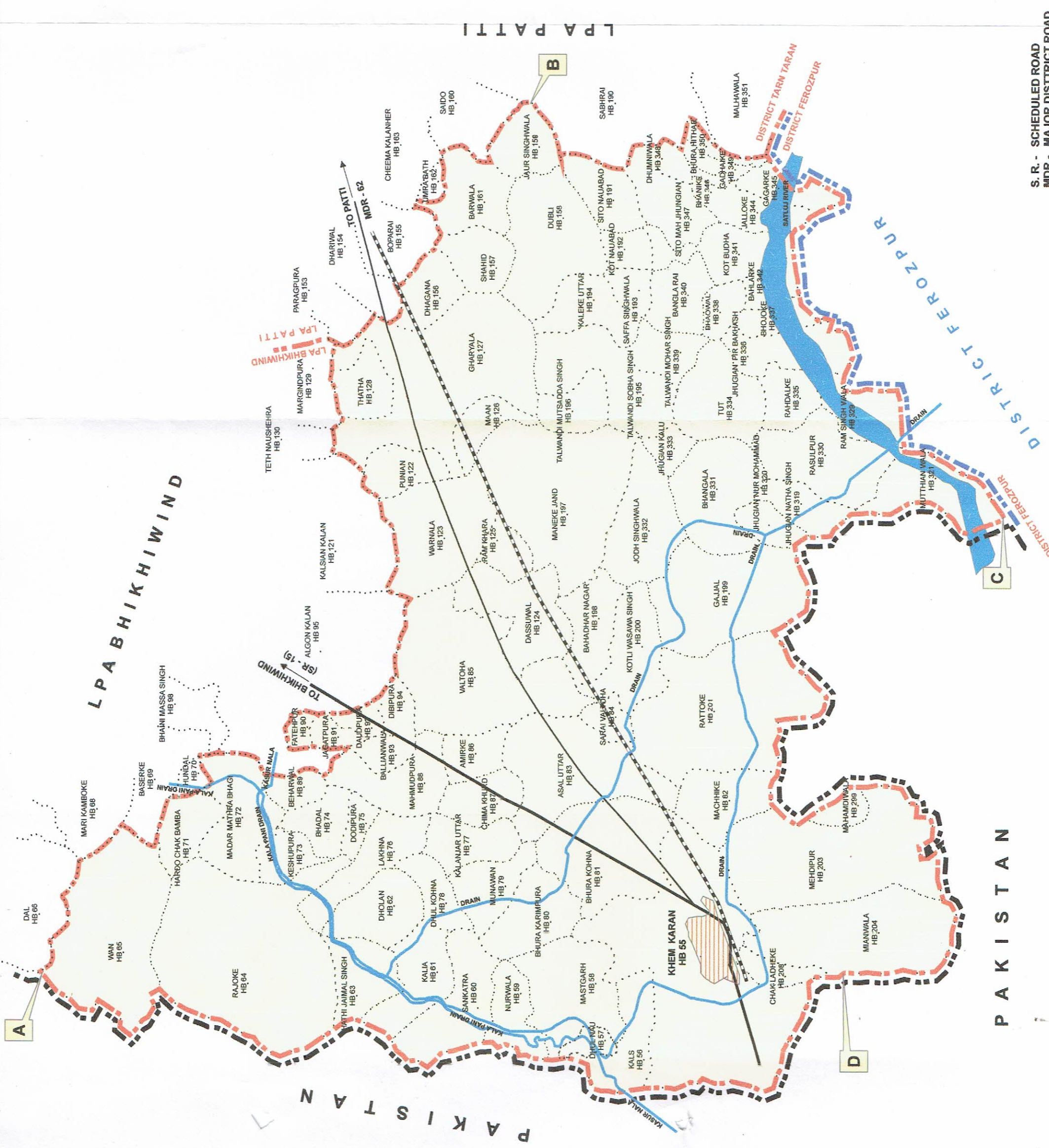
